**Requirements**

1. Photocopy of business license
2. Photocopy of sales tax permit
3. Arizona companies must submit a resale card
4. Completed dealer application
5. Business Card

**Payment Terms**

Payment will only be accepted in the form of cashiers check, money order, and approved company checks. Credit card payments will be charged a 3% fee. Cash is accepted for will call customers only. Any returned checks will be assessed a \$45.00 returned check fee.

**Returns**

All returns must be first authorized by Ksport. All authorized returns will be than issued a RA number. All incoming packages will be refused without RA number clearly written on the box. Customer is responsible for all return shipping expenses to us. Returns are subject to a 25% restocking fee.

**Shipment Terms**

All shipments will be shipped FedEx Ground or via Truck Freight

**Drop Shipments**

PO must be submitted for any dropship and must be paid via money order or cashiers check unless arranged otherwise.

**Damage Claims**

Any damaged merchandise received must file a claim with the carrier and not with Ksport.

**Shortages**

Any shortages in a shipment must be reported to the carrier upon arrival.

**Warranty**

All products sold are subject to the following warranty:

**Autoline Industries warrants the shock absorbers and steering stabilizers to the original retail consumer against defects and workmanship when used on light truck and car applications under normal operating conditions. This warranty does not apply to shocks and steering stabilizers that have been improperly installed.**

**Our warranty does not cover shock absorbers that are to be used in racing applications. Exterior finish on all K-Sport products is not considered a valid warrantee; consumers are responsible for the maintenance of paint and or chrome or plated finish.**

**Shock Boots are also excluded from any type of warrantee. ALL SHOCK BOOTS should be removed prior to returning to the Distributor from which the product was originally purchased. Rusted shafts will also be denied as a warrantee claim; consumers are responsible for the upkeep and maintenance of the chrome rods.**

**The consumer will be responsible for the removal and freight costs both to and from the Distributor from which the product was originally purchased. Proof of purchase is mandatory in order to receive warrantee replacement; original invoice from the Distributor from which the product was purchased must accompany the product in question for warrantee.**

**Autoline Industries or Autoline Industries distributor has the right to refuse a warrantee claim if procedures are not met by the original consumer. All returns must have an R.M.A. approval from Autoline Industries prior to shipping direct to the Autoline Industries facility. Exclusions from this warranty are sales outside of the United States, the finish, dents, rust, or any condition caused by abnormal use or neglect.**
